Eligibility: All UC San Diego faculty, staff, students and qualified affiliates who have a valid UC San Diego ID and are registered with the Pedal Club are eligible to apply for a Gilman Bicycle Cage access card.

Cost: \$15 processing fee for initial access card; \$15 nonrefundable fee for replacement (lost/damaged) key cards

Gilman Bicycle Cage Terms of Use

I understand and acknowledge that:

- The bicycle cage is intended for daily, short-term bicycle parking only. Long-term storage is not allowed. Bicycles left for more than 30 days may be impounded by UC San Diego Police.
- The bicycle cage may only be used for bicycle parking. Scooters, mopeds, skateboards, motorcycles or personal items may not be left inside the cage.
- UC San Diego accepts no responsibility for bicycles or personal items left inside the bicycle cage.
- You park your bicycle at your own risk. Always lock your bicycle correctly to the rack. Bicycles may not be left unlocked and unattended inside the bicycle cage.
- Bicycle cage parking is available on a first-come, first-serve basis. If no spaces are available, you may not use the bicycle cage.
- Locks or cables may not be left locked to the cage or bicycle rack.
- The user is expected to help keep the cage area clean, ensure that the door is locked and immediately report any damage to the cage or lock system to Commute Solutions, (858) 534-7433.
- In the event of a malfunction or power outage during business hours, contact Commute Solutions, (858) 534-7433; after business hours, contact UC San Diego Police, (858) 534-HELP (4357), for access assistance.
- No guests are allowed inside the bicycle cage—one person per entry.
- Only one bicycle may be stored per user. Unregistered bicycles may be impounded by the UC San Diego Police.
- The user is expected to report lost or stolen access cards within 24 hours to Commute Solutions, (858) 534-7433, and pay a \$15 lost/stolen card replacement processing fee.
- Active campus affiliation is required. Access cards may be deactivated within 72 hours of status changes.
- The bicycle cage access card is UC San Diego property it is nontransferable and nonrefundable. Resale is prohibited. Any falsification, alteration, duplication or other misuse of this access card is prohibited and may result in confiscation and termination from the program.
- Transportation Services reserves the right to deactivate access cards after 45 days of inactivity. Access cards must be returned to the Commute Solutions Office.
- UC San Diego accepts no responsibility and provides no bailment for user's property. Bicycle theft or damage of personal property should be reported to UC San Diego Police at (858) 534-HELP (4357)n
- Violations of these terms or abuse of the bicycle cage may result in immediate termination of access rights and removal from the program.
