

## Triton Commuter Club Special Challenge Day Incentive Drawings

### Official Rules

#### **1. Entry Period.**

Parking & Commuter Services periodically declares Special Challenge Days where participants may earn entries in a special drawing by participating in the challenge and logging the trip by the end of that day. Planned Special Challenge Days include:

- a. Clean Air Day (Typically during the month of October)
- b. Earth Day (April 22)
- c. Bike Anywhere Day (Typically during the month of May)
- d. Car-Free Day (September 22)

#### **2. Eligibility**

- a. UC San Diego affiliates (students, faculty, and staff only) are the only persons eligible to participate in the Triton Commuter Club.
- b. The Drawings covered by these Official Rules are only open to registered carpool drivers and Triton Commuter Club members that do not have an annual or “consecutive days” parking permit.
- c. By participating, entrants agree to comply with these official rules, the sponsor’s interpretation of them and the decisions made by the sponsor in matters relating to the contest.
- d. By participating, entrants release and hold harmless the sponsor against any and all claims, injury or damage arising out of or relating to participation in this contest and/or use or misuse or redemption of a prize.
- e. To be eligible for a Special Challenge Day drawing, participants must be members of the Triton Commuter Club on the Special Challenge Day in question.

#### **3. To Enter.**

- a. Entrants will automatically be entered when they log trips either made or avoided using the Triton Commuter Club portal in accordance with the guidelines below.

- b. Clean Air Day (Typically during the month of October) – To enter, log a non-drive alone trip or trip avoided by remote work/learning or a compressed work week using the Triton Commuter Club’s trip logging portal
- c. Earth Day (April 22) – To enter, log a non-drive alone trip or trip avoided by remote work/learning or a compressed work week using the Triton Commuter Club’s trip logging portal
- d. Bike Anywhere Day (Typically during the month of May) – To enter, log a trip by bicycle using the Triton Commuter Club’s trip logging portal
- e. Car-Free Day (September 22) – To enter, log a non-drive alone trip or trip avoided by remote work/learning or a compressed work week using the Triton Commuter Club’s trip logging portal
- f. NO PURCHASE OR PAYMENT REQUIRED FOR ENTRY.
- g. Entries received during the entry period are eligible for that period’s drawing.
- h. To enter the drawing without using the Triton Commuter Club’s trip logging portal, send a letter containing your full name, UC San Diego affiliation details, the month, or special challenge day drawing you wish to enter, and email address to: Triton Commuter Club, 9500 Gilman Drive #0011, La Jolla, CA 92093-0011. Letters must be received on the special challenge day to be eligible for that day’s drawing. Entries are limited to one entry per person per drawing. In the event that multiple entries from the same individual are received for the same drawing, only the first entry will be valid.

#### **4. Prize Winners Selection/Notification**

Winners will be randomly selected from among all valid entries received for each Special Challenge Day drawing. Winners will be notified by email. Sponsor reserves the right to select additional winners for unclaimed prizes.

#### **5. Prizes.**

- a. The odds of winning a prize depend upon the total number of participants, which is likely to vary by special challenge day.
- b. Special Challenge Day Drawings: One winner will be awarded a prize pack with an estimated retail value of \$75. Sponsor reserves the right to award additional “runner up” prizes of varying quantity and value at their sole discretion.

#### **6. General Terms.**

- a. Contest is void where prohibited by law.

- b. Sponsor reserves the right in its sole discretion to cancel, terminate, modify or suspend the contest.
- c. Entrants agree to indemnify and hold harmless the sponsor from any and all liability resulting or arising from the contest, to release all rights to bring any claim, action or proceeding against the sponsor, and hereby acknowledge that the sponsor has neither made nor is in any manner responsible or liable for any warranty, representation or guarantee, express or implied, in fact or in law, relative to the prize or prizes.
- d. Entrants agree that their name may be shared publicly in an announcement of winners.
- e. Taxes due on winnings are the sole responsibility of the winners
- f. Prize delivery will be on the UC San Diego campus in La Jolla, California.

### **7. Sponsor.**

Contest is sponsored by UC San Diego Parking & Commuter Services as part of the campaign to reduce environmental, traffic, and parking impacts from commute travel.

### **8. Disputes.**

The exclusive jurisdiction and venue for any disputes arising from this contest will be the courts located in San Diego County, California. In all cases, sponsor's liability shall be limited to the value of one prize (i.e., \$75).
